

TERMS AND CONDITIONS

RESERVATION AND PAYMENTS: All space is confirmed upon receipt of deposit on a first served basis. Deposits must accompany all reservation requests. All check and money orders must be made payable to Ambassador Travel or where the tour is sold to the Tour Participant by a retail travel agent, who in turn makes his check payable to Ambassador Travel . Final payment is due in full no later than ninety (90) days before departure. It is understood that it is the responsibility of any and all individuals or companies acting in the capacity as retail travel agent, and selling the service of this tour to their clients, to treat all such tour funds collected as monies held in trust.

PASSPORTS/VISA/TOURIST CARDS: A valid passport is required for US citizens and is the responsibility of the Tour Participant.

BAGGAGE LIABILITY AND INSURANCE: Ambassador Travel cannot be responsible for loss of, or damage to, passenger's belongings. The liability of the air carrier for loss, damage, or delay of baggage in connection with the air transportation it provides is limited and tariffs vary according to each carrier. Baggage, health, flight, and accident insurance is available from Ambassador Travel or through your retail travel agent. Members are limited to two pieces of baggage.

For those who desire to leave from another add-on city, special fares are available.

CANCELLATIONS AND REFUNDS: In the event services and accommodations set forth in this brochure cannot be supplied due to delays, acts, omissions or other causes beyond its control, the operator shall use its best efforts to supply comparable services and accommodations. In the event such services and accommodations cannot be supplied due to the above reasons, or in the event services are not used due to voluntary omission with charter by the Tour Participant, refunds will not be granted. No responsibility will be assumed for missed connections with charter flights. No changes or alternations will be made in itinerary unless it appears to be in the best interest of the participants. In such event refunds will not be granted. Ambassador Travel reserves the right to cancel any tour to scheduled departure for any reason, including insufficient number of participants; should this happen, all payments made by the Tour Participant will be refunded by Ambassador Travel. **To obtain refunds as specified applications must be submitted in writing to the tour operator. Full refund for cancellation minus \$100 received up to 90 days prior to scheduled departure. If written notice is not received by Ambassador Travel up to 60 days prior to scheduled departure, a service charge of \$250 per Tour Participant will be made. If cancellation is made less than 60 days prior to scheduled departure, there will be a service charge of \$250, and only the funds that can be recovered will be refunded to the Tour Participant.** Ambassador Travel reserves the right to require any Tour Participant to withdraw from any tour, at any time, if Ambassador Travel determines his acts or conduct detrimental to or not compatible with the interest, harmony, comfort or welfare of the tour as a group. A refund covering the daily pro-rated portion of the unfinished tour will be made to such individuals as soon as possible, but without further obligations or liability on the part of Ambassador Travel.

TOUR PRICES: Tour Prices quoted for transportation and land arrangements are based on rates expected to be in effect at the time of scheduled departure and, accordingly, are subject to change without notice. Tour price does not include transportation between the Tour Participants home city and tour departure airport; items of personal nature such as laundry, meals, beverages, and gratuities not specifically mentioned in this tour brochure. Tour Participants shall have the right to cancel the tour and receive a refund of payments made to date in the event the Tour Participant desires not to pay the increased tour price, provided written notice of cancellation by the Tour Participant is received by Ambassador Travel within five (5) days after notification to the Tour Participant of the increased tour price.

CLAIMS: Unless the Tour Participant files a claim with Ambassador Travel in writing, or if unavailable, with the surety, within sixty (60) days after completion of the tour, the surety shall be released from all liability maintained under the bond by Ambassador Travel for the protection of such Tour Participants.

RESPONSIBILITY AND LIABILITY: All arrangements and services for these tours have been made by Ambassador Travel and Cathy Howe for the tour members. Ambassador Travel and Cathy Howe are acting as principals and are responsible for the tour members in making the arrangements for all tour service and accommodations offered herein provided, however, that Ambassador Travel in the absence of negligence on its part, is not responsible for personal injury or property damage or other loss or experience arising out of act of negligence of air carrier, hotel or other person rendering any of the services or accommodations offered herein. The tour member also agrees that Ambassador Travel shall not be liable or responsible for any loss, damage, injury or expense to person, property or otherwise in connection with any accommodations, transportation or other services resulting directly or indirectly, from any causes beyond Ambassador Travel but not limited to acts of God, dangers incident to the sea or air, breakdown in machinery or equipment, acts of government or other authorities de jure or de facto, wars, whether declared or not, hostilities, civil disturbances, strikes, riots, thefts, epidemic, quarantines, medical or customs regulations, delays or cancellations of or changes in itineraries or schedules, or improper or insufficient passports, visas or other documents or failure to tour participants to comply with customs regulations.

Tour arrangements have been made by contract with the accommodations, air carriers, bus companies, or owners or contractors providing accommodations, transportation or other services and all coupons, exchange orders, receipts, contracts and tickets issued by Ambassador Travel are issued subject to any and all tariffs, terms and conditions under which such accommodations, transportation or other services are provided by such as hotels, air carriers, bus companies, or owners or contractors. By the acceptance of such coupons, exchange orders, receipts, contracts and tickets the tour member agrees to be bound by any and all tariffs, terms and conditions under which such accommodations, transportation or other services are provided. Ambassador Travel reserves the right to substitute accommodations and tour features where advisable or necessary.

Should any substantial changes be made in the tour itinerary prior to departure, participants will be notified and given the opportunity to cancel with the full refund. Tour members are advised that the provisions of a treaty known as the Warsaw Convention are applicable to the air transportation on these tours. The Convention in most cases limits the liability of direct air carriers and other air carriers to passengers for death or personal injury to approximately \$8,290, except the extent that the direct carriers have agreed to higher limits.

The tour member is also advised that in the event the air carrier providing the air transportation described herein is delayed in performance or unable to perform, the provisions of the Economic Regulations of the FAA and tariffs filed by the carrier with the FAA (which permit the air carrier to furnish alternative transportation in certain circumstances and subject to certain conditions) may govern the right and obligation of the parties.

Since June 24, 1981, the Blessed Virgin Mary has been reported to visit daily with several young adults in Herzegovina, bringing messages on how to achieve peace in our hearts, homes, and the world.
